- 5. Future funds and income
 - Sport England / Active England
 - Utilise when a specific project presents itself and done by application. There is not currently something to consider.
 - ES rebates & Membership Changes
 - o Every affiliated club we get 12.5% of Court Fees.
 - Every affiliated player we get £ 1 per person.

- The above changes in September 2023. Clubs will only pay for their courts and players would have to pay for themselves. There will be a free digital version available for players.
- It would be beneficial to promote membership in Norfolk but the benefits don't currently pose a decent enough opportunity to try and enforce paid membership.

6. CPM Update

- Junior Tournament
 - Organisation discussion. Sanctioned events would be beneficial and generate some funds.
 - Sam H is in the process of organising one at Broadland in October. This will be used as a Trial for future events at other clubs.
